3. Performance

- 3.1 Essex Police Crime Performance Report – attached **RESTRICTED** Thurrock is in a good place with regards to crime reduction and satisfaction COVID has had a national impact on crime reduction
 - Crime down 18% on this time last year which is a significant decrease:
 - Violent crime down 6.5%
 - Sexual offences down 4.1%
 - Robberies down 15%
 - Theft, burglary and vehicle theft all down 33%
 - Criminal damage down 28%
 - Racial and religious offences down 6%

Crime is at a decade long low

With regards satisfaction there has been an 18% decrease in those that think ASB has become more of a problem in last quarter, down to 23% of those asked

We have seen a 45% increase in ASB (1925 more incidents)– all COVID breaches are recorded as ASB incidents

ASB is mainly composed of COVID breaches and nuisance motorbikes Insp Terry Fisher is reviewing nuisance motorbike plans known as Op Caesar - looking at target hardening, prevention and funding Cllr Redsell requested to speak to RM offline regards the issue Cllr Redsell – need to move quicker and utilise local residents and councillors who observe nuisance motorbikes. Seem to be seeing and hearing a lot about vehicle crime but not reflected in this data RM – may be local anomalies and small pockets of these offences but year on year vehicle crime has decreased overall

Relaxing of Lockdown

Concerns that as weather gets warmer and pubs and bars start to open up we may see a significant increase in violent crime

Businesses want to recoup lost income so likely to have longer opening hours

Year on year data shows decrease in violent crime due to lockdown but majority of incidents for this year are likely to occur during the summer months

Plans are in place and there is a sharing of best practice across the force with

central funding for:

- Still a requirement over the next 2 months to police the COVID restrictions despite the easing
- 6 additional officers across the west
- 3 will be specific to Thurrock with 1 at Lakeside to specifically deal with COVID breaches
- violence suppression budget for Thurrock to provide additional policing during evenings
- 7 officers across the west, 3 dedicated to Thurrock on Thursday, Friday and Saturday evenings and later into the nights to show visible policing

In addition there will be joint community safety patrols with enforcement teams, checking licensing, etc.

Would look to use dispersal orders if anything is looking likely to happen Separate funding for Op Sceptre to address gangs and knife crime Extra officers allow police to carry on with business as usual to deal with the regular calls aswell as issues arising from lockdown lifting,

Concerns that there will be attempts by criminality to retake the streets As lockdown lifts, there is potential for gangs and county lines to try to re-establish their areas

C17 gang has been supressed to the point where they are a minimal threat to the community

G9 gang is emerging which is slightly concerning and it is clear that they

are trying to reintroduce street drug dealing – mapping exercises are taking place and police working closely with YOS

Safer Streets bid is underway which could hopefully lead to a significant uplift in CCTV for the area

Agreed to carry forward any funding left in PFCC CSP budgets into the new financial year

Looking to reopen community safety development fund in next financial year

VVU published their annual report – lots of positive work included. This was shared with the Board

Supporting work around incoming Domestic Abuse Bill, working through SETDAB to ensure well positioned to respond to the requirements of the Bill

Working with sexual abuse strategic partnership regards Sarah Everard murder

MC – have previously produced briefing for potential PFCC candidates, do we need to do something like this?

GM – Have produced information pack regards police and fire Returning officer at Colchester will be able to provide information on who the prospective candidates are – currently 4

5. Priority 3: Identify and Tackle Anti-Social Behaviour

5.1 <u>Report of TBC Housing ASB and Safeguarding Manager</u> Refreshing housing ASB strategy Jo Davies

Aiming to look at activity that is not necessarily criminal but is antisocial Non-criminal behaviour can have significant impacts on individuals and the community

Use PIE model (Prevention, Intervention and Enforcement) Prevention is about working with partners to take a neighbourhood based approach to ensure access to information and signposting for individuals into support services

Strategic approach is to intervene in cases to prevent them escalating or occurring in the first place

Important to listen to victim/local communities and ensure we provide wrap around services

Also support perpetrators who are vulnerable – seeking to change behaviour which often includes getting them involved with relevant services

Enforcement action has always been robust - actively seek to use tools and powers available

Look to engage perpetrators positively in terms of support e.g. if they have an addiction, ensuring they get help from the relevant service Provide victim support directly to residents through Housing Safeguarding team

Visiting vulnerable individuals outside of office hours when it may be more convenient and/or they may be at increased risk and also conducting safeguarding patrols

Keen that strategy demonstrates the good work already done with

community safety partners and also highlights that this work can't be done without support from residents and community stakeholders Looking for sign off from the CSP Board with any comments on what else could be included

Cllr Redsell – tend to want to use residents who are victims too often, may be putting themselves at risk by providing information to professionals and then having to live in close proximity to perpetrators. Need to look at other approaches to ensure they are protected JD – have recently changed sensitive lets. Not within policy but now considering whether areas, neighbours, blocks etc have suffered ASB in the past and review whether any complex needs of an applicant may cause these issues to flare

Cllr Gledhill – need to be looking at our approach to individuals who are constantly victims of ASB

We need to be telling success stories on behalf of victims who can't and won't be identified to reassure residents that we will take action on complaints. Need to publicise outcomes.

JD - When we get positive outcomes, local press are good at promoting the good work that has been done

Cllr Redsell – there are no local printed newspapers that are distributed to elderly residents who aren't online so may be an opportunity to use members to share success stories

JR – we have a holistic approach so that when one team's enforcement powers end, another service can step in

JD – recently got Housing Noise Officer role signed off and they will be working with the noise team to ensure we have support for council tenants

5.2 Report of CSP ASB Officer

Investigates cases and complaints where complainants and perpetrators are not in council housing and takes cases from owner occupiers, rental tenants and housing association residents

- From Jan 20 Dec 20, issued 2 CPW's, 23 noise nuisance warning letters, 6 safeguarding referrals, 2 complex ASB case review, 2 cases referred for restorative justice
- Case studies included in the report
- There are 2 PSPO's in Thurrock 1 in Grays High street, renewed April 20. 52 FPN's and 119 warnings issued to the public linked to breaching the PSPO
- West Thurrock PSPO for cruisers expires December 2021 will be gathering evidence to renew
- Monitor and target harden hotspots for nuisance motorbikes,

- Increase in domestic noise during COVID little action can be taken
- Looking to update Thurrock website to provide information on reporting
- Looking at reviewing how ASB case reviews are undertaken in 2021/22
- Further exploring use of Xantura to assist with evidence gathering
- Working closer with LAC to increase and improve resident engagement
- Difficult to obtain evidence relating to possible dogs PSPO
- Working with Essex Police Business Crime Unit in Grays and Purfleet

Pupils travel in from all different areas to go to school so pupils from 2 different schools could live in the same areas

5.3 Report of District Commander **Richard Melton** Conducted post implementation review of Town Centre Team Police including the Council funded 4 additional TCT officers Stanford Le Hopes Town Centre Team boundary extended by 1.7 miles to include Corringham **Paula Watts** 5.4 Response to Motorbike nuisance PW explained her role in managing public bridleways and explained the legal restrictions in limiting access. Mostly council land so public have right of way Bridleway 112 from Daneholes to Orsett is an issue as difficult to restrict access there. Legitimate users of these trails righty raise concerns. Support will be gratefully received and is happy to be part of a working group around the issue. JR – stressed need to look at every opportunity and angle to address the problem Cllr Redsell - most routes used are council owned

There were some barriers on the A1089 but they were removed and

recently a child was knocked over there Riders use Hangmans Wood, Chadwell, etc to enter Blackshots field MC - Environmental engagement team are engaging with land owners as it is costing them to repair broken fences, etc Cllr Gledhill – PSPO's could be used just for specific hotspot times for ASB Cllr Redsell – were talks with land owner at Buckingham Hill Road previously around using some land specifically for these bikes to have an area to ride but public liability was too expensive - could be looked into again MC - PSPO looked at before but wasn't realistic to enforce

RM – TF to bring ideas on nuisance motorbikes to next meeting

- Attends new Fairness and Equality Challenge panels
- West LPA has higher proportion of race/religious hate crime compared to other LPA's but was looked into and showed that West LPA had significantly more BAME residents
- 9 Hate Incident Reporting Centres and 222 Hate Crime Ambassadors in Thurrock
- Hate crime booklet for victims has been recently updated
- Creating pack for teacher/leaders of groups to help them to inform and educate those they come into contact with

New format, feedback requested– ALL to feedback on this format Looking at working toward Criminal Justice treatment intervention team within police and probation – possible funding for 3 staff for the team Proposal to be submitted by end of March Due to receive around £200,000 - significantly more than expected Possibility of alcohol tags aswell - trialled in Wales

Cllr Redsell – how will the rest of the funding be spent? KM – set guidance on how funding is used, split between those leaving prison and those at risk of criminality in the community Also want to support a special medical detox programme

Cllr Redsell – any possibility for apprenticeships? KM – on a one year funding cycle so difficult to bring in apprentices but young peoples' services do have apprentices

Cllr Gledhill – when will alcohol tags be introduced? ND – date for rollout of Alcohol Monitoring has yet to be agreed

Reachable moments is the time where a young person is reachable and teachable e.g. when they are arrested in police custody, injured in hospital, in trouble at school that could lead to exclusion. Ceryl has made links with police custody, hospitals etc to be alerted at whatever time of day or night so she can go and sit with young
