STATEMENT of REASONS

The Council proposes to implement Waiting Restrictions "No Waiting At Any Time" at the locations listed below to improve safety, visibility, and access by relocating parking to prevent obstruction and to maintain traffic flow on the highway;

The general effect of the Order would be to introduce new waiting restrictions "No Waiting At Any Time" at the following locations;-

- i. On the southern side of Danbury Crescent from a point 15m from the eastern kerb-line of Daiglen Drive as a continuation of the existing double yellow in a south-easterly direction for a distance of 37m.
- ii. On the northern side of Danbury Crescent from a point 15m from the eastern kerb-line of Daiglen Drive as a continuation of the existing double yellow in a south-easterly direction for a distance of 15m.
- iii. On the northern side of Danbury Crescent from a point 10m south-west from the rear eastern property wall of 3 Danbury Crescent following the kerb line in a westerly direction of for a distance of 16m.
